The examination covers the following areas of competence: Area 1: Fundamental principles and concepts of the Information Security Management System; Area 2: Information Security Management System. The French exam is a 40-question MCQ lasting 1 hour, closed-book. The course material contains extracts from the standard(s) required to pass the certification exam.
