Sub-group work on incentive and disincentive clauses in contractual relations.

3 Managing contract modifications during performance

- Modifications to contracts during performance.
- Modifications to contractual documents.
- Any additional services required.
- Change of owner.
- Non-substantial modifications.

Analysis of contract control methods and implementation of a contract security sheet.

4 Managing financial guarantees to secure contract performance

- First demand guarantee or bank guarantee.
- Holdback and advance payment.
- Assignment or pledging of receivables.
- Payment on account: special cases of co-contracting and subcontracting.
- Rejection of a payment request.

5 Payment rules

- The global payment deadline and the mechanism's implications for the various parties involved.
- Cases of suspension of the overall payment period.
- Application of interest on arrears. Additional interest on arrears.

Hands-on work

Exercise on the liquidation of default interest.

TEACHING AIDS AND TECHNICAL RESOURCES

- The main teaching aids and instructional methods used in the training are audiovisual aids, documentation and course material, hands-on application exercises and corrected exercises for practical training courses, case studies and coverage of real cases for training seminars.

7 Service monitoring and evaluation

- Performance monitoring and improvement.
- Verification of delivery of the service/product.
- Modifications at runtime.
- The main measurement indicators.
- The notion of continuous improvement in market monitoring: progress plan.
- Implementation of the Responsible Supplier Relations charter.

8 Settle disputes related to contract performance

- Dealing with a service provider in financial difficulty.
- To obtain compensation for defects discovered during the performance of the contract.
- Guarantee effective recourse against the various market participants.
- Find an amicable solution to disputes.
- Recourse or litigation.
