- The different editions of Azure AD: Free, Basic and Premium.

### Hands-on work

Implement Microsoft Entra ID in Azure.

### PREREQUISITES

Basic knowledge of Microsoft Azure administration and Active Directory on Windows Server, or knowledge equivalent to that acquired in the course "Azure, implementation" (ref. AZM).

Synchronize a forest with Azure AD Connect. Synchronize Microsoft Entra ID with a local AD. Monitor AD and Microsoft Entra ID activity by generating reports.

- Roles Microsoft Entra ID.
- Synchronization management
- Overview of governance and role configuration

### Hands-on work

Configure and manage roles (IAM/RBAC). Define role catalogs for administration groups.

## 6 User, group and applications

- User-based role provisioning and addition.
- Manage and add group-based roles.
- Customization of the authentication page visual.
- SAAS, PAAS and On Premise application registrations

### Hands-on work

Add self-service applications, one device on one user.
