Definition of patch deployment architecture and deployment.

- Patch approval and associated reports.
- Create and export root certificates for customers.

Retrieve and approve updates. Execute patch approval and generate reports.

4 Implement deployment

- Setting up WSUS Master servers.
- Computer groups on the master server.
- MASTER-WSUS server synchronization settings.
- WSUS database export procedure for/and on disconnected site.
- WSUS client deployment via regedit or GPO.
- System Center Configuration Manager 2012 R2 and WSUS 4.0
- Uninstalling WSUS 4.0.

Hands-on work

Verification of deployment and updates. Patch management from remote sites. Uninstall WSUS 4.0 from a server.

5 Use Reporting functions

- WSUS 4.0 report generation.
- update and computer reports.
- The reporting group.

Hands-on work

Use update reports, computer reports and synchronization reports.
