Managing addictive behavior is a multifaceted issue. A better understanding of the notion of addiction and its possible causes is needed to improve therapeutic efficacy and the helping relationship, while preventing the possible violence associated with this disorder.

### ASSESSMENT TERMS

- The main teaching aids and instructional methods used in the training are audiovisual aids, documentation and course material, hands-on application exercises and corrected exercises for practical training courses, case studies and coverage of real cases for training seminars.

- A check-in sheet for each half-day of attendance is provided at the end of the training, along with a course completion certificate if the trainee attended the entire session.

## 1 Scope and challenges of managing addictive behavior

- Specificities inherent in tobacco, alcohol, various drugs...
- The specific consequences of psychoactive substance use during pregnancy.
