## 1 The fundamental concepts of green taxonomy

- Defining the objectives of green taxonomy: background and regulatory framework.
- Examine the six main environmental objectives.
- Identify eligible and non-eligible activities.

### Case study

Case study: analyze examples of economic activities and determine their alignment with the green taxonomy.

## 2 Practical application of green taxonomy

- Set up methods for evaluating economic activities.
- Work on evaluating projects or companies according to green taxonomy criteria.
- Examine the tools and resources available to companies and investors.

### Case study

Interactive workshop: participants use assessment tools to analyze a fictitious or real project according to green taxonomy criteria.

## 3 Impact on companies and investors

- Analyze the implications for companies: adaptation, compliance and opportunities.
- Monitor the impact on investment strategies and portfolios.
- Present challenges and best practices.

### Group discussion

Brainstorming: consider how a specific company could align its activities with the green taxonomy.

## 4 Future planning and strategy

- Develop an action plan for integrating green taxonomy into company organizations.
- Assess the skills needed and the additional resources required.

### Hands-on work

Planning workshop: participants draw up an action plan for integrating green taxonomy in their organization or in a fictitious case.
