2 Legal aspects of the Internet

- Protecting your site's name: differences between company name, brand name, trademark and domain name.
- Automated processing of personal data: compliance with the rules governing the collection of personal data.
- Mandatory information.
- Copyright and intellectual property on the Internet.
- What about using an artificial intelligence tool (ChatGPT, Claude, Mistral, NotebookLM, Copilot, Gemini...).

3 Personal injury and how to prevent it

- Invasion of customer or employee privacy.
- The risks of identity theft.
- The risks of the cloud.
- The role and obligations of the data protection officer (DPO).
- The security obligation (RGPD, NIS 2, DORA, LPM).
- Staff training and awareness-raising.
- Dialogue with the CNIL in the event of an inspection.

Examples of personal data protection implementations. Reflection on best practices.

4 Freedom of expression on the Internet and its limits

- Defamation, insults and disparagement.
- Cyberbullying.
- Respect for privacy: personal rights, image rights.
- Content moderation and comment filtering.
- The role of platforms: a reminder of the content publisher/host distinction.

Hands-on work

Examples of privacy violations linked to the Internet and social networks. Case law examples.

5 Litigation management on the Internet

- The different types of dispute: civil/commercial, civil or criminal.
- Handling international trade: application of private international law, judicial cooperation.
- The international nature of Internet disputes: what about facts committed abroad? A co-contractor located abroad?
