- Integrate the customs and tax obligations of the authorized regime.
- Ensure that the customs office approves the stock records.

## 4 Material accounting workshop: key points in practice

- Safety/security linked to flow control.
- Input-output operations.
- Waste management operations.
- Traceability of goods and operations.
- Documentation and reporting.
- Customs control.

### Hands-on work

Practical workshop: as part of the implementation of customs accounting in a bonded warehouse, participants identify malfunctions and key points to be corrected, and recommend actions to be taken.

### TEACHING AIDS AND TECHNICAL RESOURCES

- The main teaching aids and instructional methods used in the training are audiovisual aids, documentation and course material, hands-on application exercises and corrected exercises for practical training courses, case studies and coverage of real cases for training seminars.
- At the end of each course or seminar, ORSYS provides participants with a course evaluation questionnaire that is analysed by our instructional teams.
