This training course gives you a practical understanding of the tools and ethics involved in two often confused practices: supervision and analysis of practices. You will learn how to involve staff and lead working groups in the implementation of these two approaches.

Insight into group dynamics and incident management.

3 Implementing supervisory practice

- History of supervision: antecedents and various European experiences.
- What talking means.
- Who do we supervise?
- Demand analysis.
- The clinical instance and group regulation.
- The place and position of the supervisor.

Hands-on work

4 Creating and leading a practice-sharing group: methods and tools

- The institution/stakeholder relationship.
- The creation of a practice analysis group.
- Methodology: tools and teaching aids.
- Problem definition, time management.
- GAP animation techniques: mini-workshops, tasks, group composition and breakdown.
- Individual and collective process evaluation: creative support.
- Review of best practices.

Hands-on work

Based on situations proposed or experienced by participants: practical exercises in the workshop and analysis in the large group. Each participant identifies his or her own tools and creates a summary sheet.
